IN 2021, ADVANCEMENTS WERE MADE IN THE STEM CELL RESEARCH PROGRAM. DRS HARRIS AND SADIO CONDUCTED A LONG TERM FOLLOW UP STUDY OF MS PATIENTS IN THE PHASE I CLINICAL TRIAL, WHICH WAS PUBLISHED IN THE JOURNAL NEUROLOGY NEUROIMMUNOLOGY AND NEUROINFLAMMATION.
