TISCH MS RESEARCH CENTER OF NEW YORKS (TISCH MSRCNY) MISSION IS TO CONDUCT MEDICAL RESEARCH DIRECTED TOWARD DISCOVERING THE CAUSE OF AND EVENTUAL CURE FOR MULTIPLE SCLEROSIS. IN 2019, 45 STUDY SUBJECTS WERE RECRUITED TO PARTICIPATE IN THE PHASE II CLINICAL TRIAL OF STEM CELLS IN MS, AND 25 SUBJECTS BEGAN THE TREATMENT PHASE OF THE STUDY. IN ADDITION, THE U.S. FOOD AND DRUG ADMINISTRATION (FDA) AND INSTITUTIONAL REVIEW BOARD (IRB) GRANTED APPROVAL TO BEGIN ADMINISTERING STEM CELL TREATMENT TO MS PATIENTS UNDER A COMPASSIONATE USE (EXPANDED ACCESS) PROTOCOL. OTHER PROGRAM ACCOMPLISHMENTS INCLUDE THE FOLLOWING: IN JANUARY 2019, SCIENTIST DR. NICOLAS DAVIAUD, WAS RECRUITED TO START AN ORGANOID RESEARCH PROGRAM AT TISCH MSRCNY. DRS JAMES STARK AND SAUD SADIO, ALONG WITH CLINICAL RESEARCH ASSISTANTS AT TISCH MSRCNY, PUBLISHED A PAPER ON THE LONG TERM EFFECTS OF INTRATHECAL METHOTREXATE IN PROGRESSIVE MS PATIENTS. ONE OF THE MOST IMPORTANT GOALS OF TISCH MSRCNY IS TO PROVIDE RESEARCH OPPORTUNITIES FOR YOUNG SCIENCE GRADUATES THAT ENABLE THEM TO BECOME CAREER SCIENTISTS AND DOCTORS. SINCE ITS INCEPTION, THEY HAVE TRAINED OVER 100 COLLEGE GRADUATES AS RESEARCH ASSISTANTS (RAS) FOR 2-YEAR ROTATIONS. IN 2019, ALL SECOND YEAR RESEARCH ASSISTANTS, UNDER THE GUIDANCE OF TISCH MSRCNY PRINCIPAL INVESTIGATORS, MATRICULATED TO TOP MEDICAL SCHOOLS AND GRADUATE PROGRAMS. FELLOWSHIPS IN MS RESEARCH ARE ALSO OFFERED TO PHYSICIANS AND SCIENTISTS INTERESTED IN ENTERING OR EXPANDING THEIR WORK IN THIS FIELD. THE CENTER PUBLISHED A PAPER IN EBIOMEDICINE, AN ONLINE JOURNAL.
