TISCH MS RESEARCH CENTER OF NEW YORK'S (TISCH MSRCNY) MISSION IS TO CONDUCT MEDICAL RESEARCH DIRECTED TOWARD DISCOVERING THE CAUSE OF AND EVENTUAL CURE FOR MULTIPLE SCLEROSIS. THESE RESEARCH INITIATIVES INCLUDE:

- TO BETTER UNDERSTAND AND TREAT COORDINATION AND BALANCE DIFFICULTIES IN PATIENTS WITH MS.
- TO CREATE AN EXPERIMENTAL MODEL OF PROGRESSIVE MS THAT WILL ENABLE US TO BETTER UNDERSTAND AND TREAT PATIENTS WITH SECONDARY PROGRESSIVE MS (SPMS) AND PRIMARY PROGRESSIVE MS (PPMS).
- TO UTILIZE NOVEL CEREBROSPINAL FLUID BASED ANIMAL MODELS TO BETTER UNDERSTAND OTHER NEURODEGENERATIVE DISEASES SUCH AS MS AND ALS

IN 2024, DRS HARRIS AND SADIQ PUBLISHED THE FINAL RESULTS OF THE PHASE II CLINICAL TRIAL TESTING AUTOLOGOUS BONE MARROW-DERIVED STEM CELLS (MSC-NP) IN PATIENTS WITH PROGRESSIVE MS. THE STUDY WHICH WAS CONDUCTED AT TISCH MS AND PUBLISHED IN STEM CELL RESEARCH AND THERAPY DEMONSTRATED A THERAPEUTIC EFFECT IN WALKING OUTCOMES IN A SUBSET OF PATIENTS, AS WELL AS EFFECTS IN BRAIN ATROPHY AND CEREBROSPINAL FLUID BIOMARKERS.
