SOME OF THE PROGRAM ACCOMPLISHMENTS INCLUDE THE FOLLOWING: IN OUR STEM CELL RESEARCH WE HAVE MADE ADVANCES IN USING BONE MARROW-DERIVED STEM CELLS AS A REGENERATIVE THERAPY FOR MULTIPLE SCLEROSIS AND HAVE PUBLISHED AN ARTICLE BY DRS.
